Generally, you must pay all the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u>?	Yes. In- <u>network</u> services for <u>preventive care</u> /independent labs/prosthetic limbs/outpatient mental health/chemical dependency and services subject to health and drug card <u>copayments</u> (except inpatient facility <u>copay</u>) are covered before you meet your <u>deductible</u> . Does this plan provide Minimum Essential Coverage? Yes
